Taxable services are: Account Balancing and Research Assistance, Business Deposited Item - Returned Unpaid, Counter Checks, Debit Card Hot Card, Debit Card Temporary Limit Increase, Debit Card Replacement Fee, Merchant Resolution, Paper Statements, Positive Pay: ACH, Positive Pay: Checks, Transfers and Sweeps, Stop Payments, Dormant Fee on Checking.

NSF and Overdraft Items may be imposed by means of check, in-person withdrawal, ATM withdrawal, or other electronic means.
